1. RANGE LOCATION: The Ben Avery (Black Canyon) Shooting Range, 25 miles North of Phoenix, AZ. ½ mile West of I-17 on the Carefree Hwy.(Exit 223).
2. FACILITIES: A camping area with electricity, water and toilet facilities is available, during the matches, for competitors only. Soft drinks are available but, bring your own lunch.

THE SLEEP INN PHOENIX-NORTH HAS GIVEN US THE RATE OF \$80.00 PER NIGHT FOR 2 PEOPLE PER ROOM. THEY ARE HOLDING A LIMITED NUMBER OF ROOMS. WHEN YOU CALL TO MAKE YOUR RESERVATIONS ASK FOR THE ARIZONA STATE RIFLE AND PISTOL ASSOCIATION RATE. THE NUMBER IS (602) 504-1200

3. RULES: Current NRA High power Rifle Rules will apply.
4. ELIGIBILITY: Open to any individual
5. ADVANCE ENTRIES ARE REQUIRED: All individual entries must be paid in advance.
6. INDIVIDUAL ENTRIES: Make entry in individual events on the enclosed Registration & Entry Form (NRA membership number must be included). Entries MUST be accompanied by check, money order or NRA points.

Fees paid by those unable to attend will be refunded upon request, less a \$10.00 service fee, providing cancellation is made prior to 6:00 PM, Monday, 28 March 2011. There will be no refunds for those canceling after that time.
7. ENTRIES CLOSE: Individual close 6:00 PM, Friday 28 March 2011. Entries RECEIVED after 6:00 PM, Friday, 28 March 2011 are considered late entries and may be accepted to fill vacancies on existing relays only, with a late entry fee of \$20.00.
8. ENTRY LIMITS: 180 Individual entries.

Military competitors must make arrangements to pay all fees at the Match.

LATE ENTRY FEE: \$20.00 Additional

CHALLENGE FEE: \$1.00.

PRACTICE FIRING: There will be practice firing on Wednesday 31 March starting at 9:00AM.
There will be a charge of \$12.00 for practice, please pay the range officer.

10. SQUADDING: All matches will be squadded. Squadding tickets for individual matches will be issued at the Stat. Office starting at approx. 7:00 AM each day. A competitor who fails to obtain his squadding ticket by 7:30 AM will only be squadded to fill up vacancies. NRA membership & Classification Cards must be shown before squadding tickets will be issued.

11. TARGETS: SR at 200 yds., SR-3 at 300 yds., MR-1 at 600 yds..

12. TARGET SERVICE: Target pullers will not be provided. Competitors will pull their own targets.

13. EMPTY CHAMBER INDICATOR (ECI): An approved NRA empty chamber indicator is required to be in your rifle except during the preparation period the firing of your relay. Those not having an ECI may purchase one at the Stat. office for \$1.00 each.

14. SCORING: Competitors will score. Any competitor failing to perform their scoring duties may be disqualified.
15. CLASSIFICATION: NRA High Power Classification will be used. Rule 19.6 "Assigned classification" may be used. Those unclassified or without proof of classification, will be required to compete in the Master class. Please indicate classification on the registration & entry form.
16. DIVISION BY RIFLE: S Division, Service Rifle. M Division, NRA match rifle.
17. CATEGORIES: Service (Includes Reserve, and National Guard) & Civilian.
18. AWARDS: Monetary awards will be given to the Match Winner and to the high individuals in each Division Category/Class award group on Thursday, Friday, Saturday & Sunday, for Matches #1, #2, #3, #5, #6, #7, #8, #10, #11, #12, #13, & #14 in accordance with a schedule which will be posted at the stat office prior to commencement of firing. Berger bullets will be awarded to Match Winner and to the high individuals in each Division Category/Class award group on Thursday, Friday, Saturday & Sunday for Matches #4, #9, #15, #16, & #17. Award groups must contain a minimum of 5 competitors or they will be combined with the next appropriate award group per policy. Second, third, fourth place, etc. awards will be given based on one award for each seven (7) competitors, i.e. second 8-14, third 5-21, etc..
- SPECIAL INDIVIDUAL AWARDS: In Match #17 a High Junior, High Woman, and High Senior, and High Grand Senior will be given if there are 5 or more entries.
- NOTE: An individual winning a place award (Winner, 2nd, or 3rd Open) shall be entitled to Special Awards for which he or she is qualified, but may not win a Category/Class award in the same match.
19. CHALLENGE PERIOD: The challenge period ends ½ hour after the posting of the match results.

MATCH 6: 200 yds. rapid fire sitting, 2 sighters & 2 ten-shot strings, rapid fire, 60 seconds per string. Rule 5.8 or 5.10 SR target.

MATCH 7: 300 yds. rapid fire prone, 2 sighters & 2 ten-shot strings, rapid fire, 70 seconds per string. Rule 5.6 SR-3 target.

MATCH 8: 600 yds. slow fire prone, 2 sighters & 20 shots for record, 22 minutes. Rule 5.6 MR-1 target.

MATCH 9: An aggregate of matches #5, #6, #7, & #8.

MATCH 10: 200 yds., slow fire standing, 2 sighters, 20 shots for record, 22 min. Rule 5.12 SR Target.

MATCH 11: 200 yds. rapid fire sitting, 2 sighters & 2 ten-shot strings, rapid fire, sitting or kneeling, 60 seconds per string. Rule 5.8 or 5.10 SR target.

MATCH 12: 300 yds. rapid fire prone, 2 sighters & 2 ten-shot strings, rapid fire, prone, 70 seconds per string. Rule 5.6 SR-3 target.

MATCH 13: 600 yds. slow fire prone, 2 sighters & 20 shots for record, 22 minutes. Rule 5.6 MR-1 target.

MATCH 14: 600 yds. slow fire prone, 2 sighters & 20 shots for record, 22 minutes. Rule 5.6 MR-1 target.

MATCH 15: An aggregate of matches #10, #11, #12, #13, & #14.

MATCH 16: National Match Course. Individual and Leg match fired concurrently.

The National Match Course (50 shots) No Sighters.

Stage 1: Slow fire, 200 yds, 10 shots standing. Time: 10 min. SR Target. The sling must be attached to the rifle but must be used for support.

Stage 2: Rapid fire, 200 yds, 10 shots sitting or kneeling. Time: 60 seconds. SR Target.

Stage 3: Rapid fire, 300 yds, 10 shots, prone. Time: 70 seconds. SR-3 Target.

Stage 4: Slow fire, 600 yds, 20 shots, prone. Time: 20 minutes. MR-1 Target.

MATCH 17: The SOUTHWESTERN NATIONAL CHAMPIONSHIP

An aggregate of matches #9, #15, #16.

MATCH 16a: CMP Leg Match. Leg match fired concurrently with match #16.

Individuals who wish to shoot "Leg Match" will have to pay an additional \$10.00 fee which will go to the CMP.

To fire the (CMP) Service Rifle "LEG" Match. It is not necessary to enter the NRA Matches to fire this event.

COURSE OF FIRE: The National Match Course (50 shots) No Sighters.

Stage 1: Slow fire, 200 yds, 10 shots standing. Time: 10 min. SR Target. The sling must be attached to the rifle but must not be used for support.

Stage 2: Rapid fire, 200 yds, 10 shots sitting or kneeling from standing. Time: 60 seconds. SR Target.

Stage 3: Rapid fire, 300 yds, 10 shots, prone from standing. Time: 70 seconds. SR-3 Target.

Stage 4: Slow fire, 600 yds, 20 shots, prone. Time: 20 minutes. MR-1 Target.

CMP LEG MATCH

1. OPEN TO: Any citizen of the United States 16 years of age or older.
2. RULES: This match is governed by the rules prescribed by the Civilian Marksmanship Program (CMP). (See CMP Competitions Rules and Programs).

3. ENTRY LIMITS: 180 competitors, priority to non-distinguished.
4. AUTHORIZED ARMS: US Rifle Cal 30M1/M1NM; US Rifle Cal 7.62 M1/NM; US Rifle Cal 7.62 M14/M14NM; Rifle Cal 7.62mm M1A, having not less than 4 1/2 lb. trigger pull, with standard stock and sights as issued; or the US Rifle Cal 5.56mm M16 series or commercial equivalent, as prescribed for use in the National Matches.
5. AMMUNITION: NOTE: Competitors must now furnish their own safe ammo having the following characteristics. Ammunition may be commercially manufactured or handloads. Projectile will be a full metal jacket with a pointed tip. No flat tip or round nose. The projectile may have a "ballistic" hollow point such as that used in the current military M852 style, 168 grain, 7.62mm arsenal match round. These guidelines will apply to all authorized service rifle calibers, i.e., 7.62mm (.308), 5.56mm, and caliber .30 (30-06). There will be no restrictions placed on bullet weight or muzzle velocity.

Credits toward Distinguished Designation and appropriate Excellence-in-Competition badges, as provided in AR 920-30 will be provided by the CMP.
